AMF Distribution

In accordance with AMF regulations, all information distributed to the market via Business Wire as well as additional information not disseminated in full-text to the market must be furnished to a secure AMF interface.

- ▶ All Business Wire France Disclosure news releases are automatically forwarded to the AMF.
- ▶ For documents not sent in full-text over the news wire you are required to upload the PDF documents onto Business Wire Connect for dissemination to the AMF. Documents include:
 - Annual Financial Reports
 - Half Yearly Financial Reports
 - Quarterly Financial Information
 - Report on Corporate Governance and Internal Audit

In addition, you are required to provide a notification (Document Availability Notification) for transmission to the AMF and the market via a recognised France Disclosure network.
